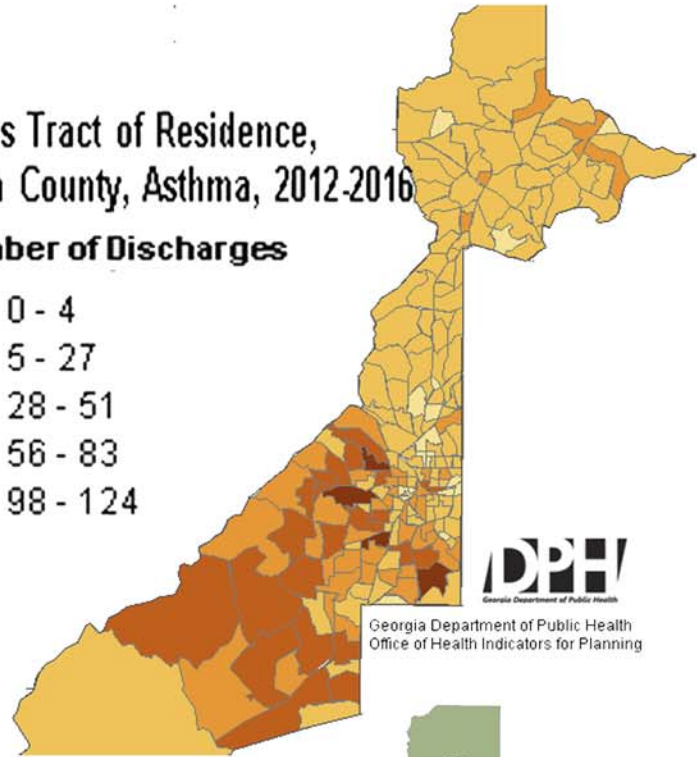
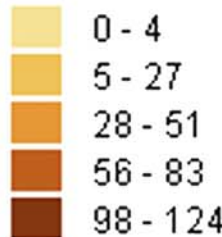
“While there were improvements in the Adamsville area, they were less than the County as a whole,” the Report continued.

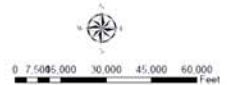
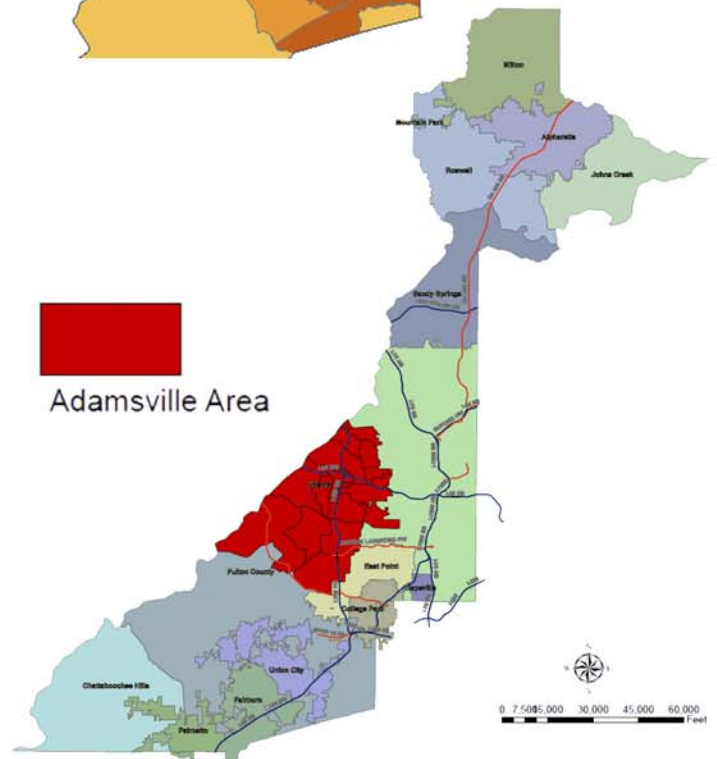
Census Tract of Residence,
