A Pilot Program to provide transportation services by Uber for Senior Multipurpose Facility participants and to authorize payment for such services in the amount of \$10,000 APPROVED. The County Attorney indicated that under applicable law, Official Code of Georgia Annotated (O.C.G.A.) 36-36-113, a County's objection to a proposed annexation cannot be based upon the validity of the application rather, the objection must be based upon the use of the land to be annexed.

For an objection to be valid the proposed change in zoning or land use must differ substantially from the existing use suggested for the property in the County Comprehensive Zoning Plan.
