# Noise pollution worse in minority neighborhoods; traffic a major culprit metro Atlanta part of national study

A new study from the University of California at Berkeley and recently published in the journal Environmental Health Perspectives found that "noise pollution is worse in minority neighborhoods and segregated cities." The study also suggests traffic including "highways" is a major culprit.

Maps show "a large swath" of noise pollution around metro Atlanta airports, including Hartsfield-Jackson and Fulton County (Charlie Brown) airports. Affected areas could also be exposed to noise from "airports and

highways up to 80 decibels," the study indicates.

Studies have also shown "that noise pollution can lead to hearing loss, stress, sleep deprivation and high blood pressure. "Hot" highways and streets located near predominately minority communities in metro Atlanta included: Camp Creek Pkwy; Fulton Industrial Blvd/Cascade Palmetto; Campbellton-Redwine Rd.; Hwy 29 (Roosevelt Hwy.); Spur 14 (South Fulton Pkwy.); Old National Hwy.; I-20; I-85; Hwy 92 (Spence Rd.); Hwy 138 (Jonesboro Rd.); Hwy. 74(Virlyn B. Smith Rd.); Gullatt Rd.; Rivertown Rd.; Martin Luther King Jr. (near Charlie Brown Airport); Oakley Industrial; Buffington Rd.

In a recent (unscientific) survey of up to 150 District 6 residents titled "Proximity to County Facilities" including senior centers, health centers, arts centers and interstates/highways, the survey disclosed that less than three percent of residents participating in the survey lived within five miles of a county facility. However,

87% lived within five miles of an interstate/highway.

## District 6 Summer Youth Intern Completes Project, "Fulton's Legislative Process"


On August 1, Justin Bohannon successfully completed his Summer Project: "Fulton's Legislative Process: "From Situation to Legislation (BOC Resolution)"

## Tax Commissioner COSF Contract Approved Voting Yes: Arrington, Darnell, Eaves, Ellis, Morris. Voting No: Hausmann.

"There may be two issues," Commissioner Darnell stated. "Both are related to the simple issue of FAIRNESS."

1) Should one Fulton employee or elected official be paid \$300,000 when 1,000 (employees)—who work 40 hours each week are eligible for food stamps? 2) Two North Fulton cities and the City of Atlanta pay the Tax Commissioner's fee above his salary. However, if the BOC does not pass the subject legislation, the City of South Fulton cannot?

The answer to both questions is NO. It is not fair.

"I plan to work with State Rep. Roger Bruce and others to change "the fee provision" of state law relating to a Tax Commissioner's compensation. However, I am sure that because he is a resident and strong supporter of the City of South Fulton, Dr. Ferdinand (Fulton County's Tax Commissioner) will donate his \$40,000 fee to support the City of South Fulton," Darnell stated.
